If the recency effect is solely due to items still residing in short-term memory, the delay should eliminate it, as the intervening task would overwrite the information. However, if the primacy effect and recency effect are separate phenomena stemming from different memory systems, the manipulation would affect only the recency effect.

### The Findings: Revealing Dual Memory Systems

The results strongly supported the hypothesis of two separate memory systems. In the immediate recall condition (no delay), participants exhibited both a strong primacy effect and a strong recency effect, mirroring the classic serial position curve. However, in the delayed recall condition, the recency effect was significantly reduced or eliminated, while the primacy effect remained largely intact. This

demonstrated that the recency effect is indeed due to the temporary storage of items in STM, easily disrupted by a distracting task. The primacy effect, on the other hand, represents items that have been transferred to LTM through rehearsal. Repeated exposure to the early words allowed sufficient time for them to be encoded and stored in long-term memory, resisting the effects of the delay.
